Birch (Selsdon)

Birch (Selsdon) is due to start taking reservations from 29th March. They have been invited to give a presentation at our AGM, coincidentally also on that date. It will be good to hear more from them, hopefully at our AGM. In the meantime, 'Inside Croydon' have had this message from them about the cessation of access for the public to walk there.... "Soon, we will begin to enclose the space as we transition the golf course into a wildland with free roaming cattle, pigs and horses, and an abundance of natural habitats. Keeping our animals and the public safe is our priority, so access is now no longer permitted, and once the fence has been erected, it must not be crossed. This is a privately owned estate with no public right of way. Should you still wish to continue to enjoy access to the estate, we will soon be publishing details of how to join Birch (Selsdon)." We have heard that membership is £150 per month – not sure if that is single membership or for a family, though!



Trees in Selsdon Recreation Park

The SRA has planted three trees in the Selsdon Recreation Park to commemorate last year's Jubilee and the forthcoming Coronation. Two (a copper beech and a sweet chestnut) were grown by a resident and another sweet chestnut was re-homed from the Wilderness heritage garden in Shirley as

it was surplus to requirements there. If you walk through the Rec, please take a bottle of water to give them a drink. We hope people living near them and the nursery school will also nurture them, especially in those long hot days of summer we are all looking forward to.

COUNCILLORS' NOTES

COUNCIL TAX

As residents are probably aware the government has given permission for Croydon Council to increase Council Tax by 10% more than other Councils without requiring a referendum. This will mean a total council tax increase of 14.99 per cent this year. The Council's budget, which includes the rise will be approved in early March. There are schemes to protect the most vulnerable.

This very regrettable increase is due to the bankruptcy of the Council caused by the previous administration. It is a one-off to bring the Council finances back on a sustainable basis. In future years there is no intention for there to be any increase beyond the government cap. The Council is also in negotiation with the government on solutions to the Council's unsustainable £1.6 billion of debt.

THE PENN REPORT

The long-awaited Penn Report into how the Council got into financial difficulties will be considered at a meeting on 23rd February and hopefully published soon thereafter. The Kroll report into financial irregularities related to the Fairfield Halls refurbishment, will be considered at a meeting on 23rd March. Dependent on the content of these reports, referrals to the Police and/or to professional bodies may follow.

ULTRA LOW EMISSION ZONE ('ULEZ')

The Mayor of London has announced that he wants to extend the ULEZ across all London boroughs, including Croydon, from Tuesday 29th August 2023. The Mayor of Croydon, Jason Perry, has declined to authorise the signature of an agreement which would enable the GLA to install cameras on Council property.

Several other outer London boroughs have launched a judicial review of Mayor Khan's decision. Croydon is unable to join them due to financial constraints.

New NHS trial to free up hospital beds in Croydon

The winter period is always challenging for the NHS and social care, and it is particularly challenging this year because flu is in high circulation. It has therefore never been more important to get people out of hospital on time – to benefit patients and help our fantastic NHS staff make space for those who need urgent care.

That's why I am delighted to confirm that Croydon is one of just six areas

in the country selected by the Government to benefit from a trial of new innovative solutions to free up hospital beds, make sure patients are getting the right care at the right time and allow ambulances to get back on the road quicker.

As part of the trial, One Croydon Alliance will pilot the use of a fully integrated team between acute and community, an integrated IT system, integrated financial systems and integrated leadership, and improve coordination between hospitals and community care settings like rehabilitation services.

In total, up to £14.1 billion additional funding will be invested by the Government nationwide over the next two years to improve urgent and emergency care and tackle the backlog in the NHS – the highest spend on health and care in this country's history. This is all great news for local residents and will support the work I have been doing with local NHS leaders to get extra capacity provided across Croydon South, which has already led the creation of a new elective operations centre at Purley Hospital and will eventually see the old CALAT site in Coulsdon developed into medical facilities.

Development of Selsdon Park Hotel

It was fantastic to recently be involved in discussions about the exciting plans for the development of Selsdon Park Hotel. I understand that once completed, Selsdon Park Hotel will contain almost 200 bedrooms, a lido, a wellness space, a co-working hub, activity studios, several communal spaces, three bars and two restaurants fronted by reputable chefs who place a strong emphasis on using home grown and local produce. Alongside this, the grounds are also set to include art studios, an arcade, a kids' club, as well as running and cycling trails.

I wish the owners of Selsdon Park Hotel every success in their new venture, which looks set to be a fantastic local amenity benefitting Selsdon residents and beyond.

A Good Time for Gardening – March

Spring should definitely be evident by now. It's just wonderful how these early plants cope with such extremes of temperature.

Take time, before the plants start growing vigorously, to tidy up flower beds and borders. Especially keep an eye on the weeds, as they seem to start growing earlier than everything else in the garden. Make this a general tidy up, removing leaves and other debris. Old growth on grasses etc can be cut back, or these can be left for the wildlife to use. The sparrows love bits of pampas grass to line their nests.

Make sure that greenhouses are clean and ready for any seedling and cuttings. The cleaner the glass is, the more light that will be let in, as well as removing homes for potential pests and disease. Washing pots and seed travs also helps to prevent disease. Allow the breeze to waft through the greenhouse for a few days after this, so it dries thoroughly.



Time to go on a bug hunt ... look closely at the crowns of plants and check for slugs, snails and other beasties sheltering there for the winter ... all ready to munch on the new tender shoots over the next few weeks.

Consider installing a water butt to make the most of any rainfall. This is the best type of water for plants, especially camellias and blueberries.

When there is a little bit of warmth in the sunshine it is the ideal time to check fence panels, gates and trellises for any signs of damage. Fixing now will stop the weight of growing plants bringing these down and also, they are easier to access should you be treating them with preservative.

Also check over the garden tools. Make sure they are clean and sharp. This will help to preserve them and help prevent the spread of disease. Remember to include secateurs in this cleaning task. Once clean and sharp, spray with WD40.

older half-sister Elsie – and he knew of another half-sister, Iris, who was illegitimate. His mum was quite a girl! She married three times – her first husband died very young while she was expecting Elsie. Her second husband died in February 1928 – in April of that year she married my grandfather (he was 26, she was 43) and in the July Pa was born! Doing some family research recently, I discovered, through DNA ancestry, Iris's offspring and also the fact that my grandmother had had a second illegitimate daughter by the same father, that we knew nothing about. Amazing for my dad to discover this so late in his life.

His childhood wasn't great – he was fostered out at one point, when his dad left the home to be with a 15-year-old (it was in the papers!). He had vivid recollections of his father waking him up to see the Crystal Palace burn down on 30th November 1936.

When my grandad returned, they decided to move to Selsdon, which was then a very new development. In 1938 when Pa was nine, they moved to 2 York Road. He said it was a whole new world – being in the countryside!

Pa remembered my gran packing sandwiches and a drink and, at the age of around 12, he would go off on his bike for whole days – including down to Brighton and back! He also played cricket on Selsdon Recreation Ground, where my grandfather used to umpire, and sang in the choir at St John the Divine in Upper Selsdon Road.

On his explorations he met with the Rhodes family, who lived in and worked one of the many smallholdings that then stood in Selsdon Park Road. Ivy and Henry ran a pig and poultry farm and had two children, Avery and Freddie. Freddie and Pa were the same age and became the best of friends. We still have their journals in which they would write up films they'd seen. Because his home was not the best place to be, Pa spent most of his time with this family and it's where he developed his love of gardening and growing fruit and vegetables.

Pa was stationed at RAF Benson for two years' national service - I'm told that he went in to this experience as a cowed, under confident and reserved young man – but came out changed. It was here that he started his great love affair with the River Thames. He and his comrades would spend any spare time on the river. He became a great fan of Jerome K Jerome, exploring his home village of Ewelme and the surroundings, and was a member of the JKJ Society for many years.

Sadly, in 1946, at the age of 18, Freddie Rhodes died at Mayday Hospital following surgery. After this Pa became very close to Freddie's sister, Avery (six years older than him) and on May 5th 1951 they married at St Mary's Addington.

Ivy and Henry gave them some of their land and they had a small twobedroom bungalow built (6 Selsdon Park Road).

I was born in May 1956 and was all set to be an only child as my mum had been told she couldn't have any more children – but, lo and behold, my adored sister Henrietta appeared on my mum's 43rd birthday in 1964. We had a lovely childhood - collecting warm eggs from under hens, helping to pot up plants, harvesting and selling fruit and vegetables. We found birds' nests in the long hedgerow which grew between our long, long garden and the bridle path, and identified wild flowers with the aid of our Observer's books.

We have fond memories of seaside holidays at Bexhill and Winchelsea – flying kites with Pa, going fishing, exploring rock pools, going to circuses and fairs – and the enormous excitement of going 'abroad' on our first holiday to Wales in 1967.

Life lessons – Get your affairs in order

One of the lessons of life is that we are best to prepare in advance for what is to come. Sadly, we know that we will face illness, old age and death for our loved ones and ourselves at some point. It is something we often prefer not to think about (as though we were 'ill wishing') and therefore put any organisation or planning onto the 'backburner' and think we will deal with it 'when the time comes'. Unfortunately, we can't always know in advance when that will be.

Wills

Do you have a Will, do you and your loved ones know where it is and is it up-to-date?

A will is a legal document where you say what you want to happen to your money, property and belongings (your estate) when you die. To be legal, a will needs to be prepared and

written in the right way. Your will should be easy to find when needed. (A safe and secure way is by lodging your will with the Probate Service.) It is important to update your will when your circumstances change. Your will is used to:

name your executors (who will manage your financial affairs) distribute your estate (say who your house, pets, belongings or savings will go to) provide for children under 18 reduce inheritance tax

Sort out your paperwork

Your executor/s will need to be able to find all the personal documents and the paperwork and/or passwords relating to your assets. Does your filing system need some work?

Funerals

Understandably, some people find it depressing and unsettling to discuss their funeral before they die. However, even giving your loved ones/ executors a preference on cremation or burial would be very useful, for

as soon as a death is registered this choice must be made for the official record. Funerals can also be very expensive so it is worth giving this some forethought.



Lasting Power of Attorney

Sometimes through illness, injury or old age we can no longer care for or manage things for ourselves. You can nominate one or more trusted people to make decisions on your behalf when you are unable to do so. You can create a document ahead of time to activate these decisions when you need it called a 'Lasting Power of Attorney' very easily and relatively cheaply via the Government website. There is one for Property and Financial affairs and another for Health and Welfare. If you are unable to manage your affairs and you don't have a lasting power of attorney in place, your loved ones will have to apply to the courts to have someone appointed to manage your affairs, costing time and money.

Whilst it isn't easy to think about (and action) all of the above it is really important and worthwhile to do so and there are charities and websites that can help you.

Council Tax Discounts and Support

Sole occupier discount and disregarded persons

If you are the only adult living in your property, you can

apply for a sole occupier discount of 25% off your bill. The sole occupier discount can be awarded where there is only one adult over the age of 18 living at the property. This will give a council tax reduction of 25%.



Who is eligible for this discount

There is usually no discount if 2 or more adults live in your home. However, certain people are not counted because of their circumstances. These people are termed 'disregarded'.

If there is only one adult living in the property after we have excluded the 'disregarded' people, you will be entitled to a discount of 25%.

If all occupants are disregarded you will be entitled to a 50% discount or possibly an exemption.

Who is disregarded

The following people are 'disregarded' or 'not counted' when the council works out council tax discounts:

- young people who are 18 years old, if child benefit is still in payment for them
- 18- and 19-year-olds in further education
- recent school or college leavers if they are under 20 years old
- full-time students
- some foreign national spouses and dependents of full-time students
- foreign language assistants
- apprentices
- youth training trainees
- people who are 'severely mentally impaired'
- some carers
- prisoners and other people held in detention
- residents of nursing homes, care homes and some hostels
- members of religious communities, for example nuns and monks
- patients living in hospital long term
- members and their dependents of international headquarters and defence organisations such as NATO
- members of visiting armed forces and their dependants
- foreign diplomats

You can only get this discount based on your normal living situation. You cannot get it if other people usually live with you but are away on a temporary basis. For example, you cannot get this discount for the times when the other residents are on holiday or are working away from home.

Disability

If you or someone you live with has a disability, you may be entitled to a reduction in the amount of council tax you pay. This is called a reduction for disabilities.

Council Tax support

If you're on a low income or receive benefits, you can apply for council tax support to help pay your council tax bill. Your bill could be reduced by up to 100%. You can apply if:

- you own your home
- you rent
- you are unemployed or working

Dear Reader, it is easy to be sucked down into the 'Rabbit Warren of Research' when attempting to put together these monthly missives. After putting to bed, I thought, last month's piece on the origins of our Selsdon Vale, Forestdale and Ashen Vale I stumbled into another rabbit hole, courtesy of Ted Frith's 'Selsdon Journals' and the chance find of another photo of the Selsdon Vale smallholdings.

Ted makes mention several times in his writings of unconnected events surrounding the Selsdon Garden Village Trust (SGVT) and Addington Smallholders Ltd (ASL). Efforts to join the dots have revealed the surprising scale of the smallholder's enterprise:

In 1937, at the AGM of the SGVT, it was recorded that the number of smallholders amounted to some 111. 77 on the Addington Estate (now Forestdale), 29 on Selsdon Vale and 5 on Ashen Vale. 15 acres of land were vacant. On 1st January 1936 the foundation stone had been laid for a Farm House Cafe based at the site of the ASL depot situated at the junction of Featherbed Lane and Selsdon Park Road. The building was designed by Malcolm Sharpe (*) on the site of a depot and contained a shop with cafe / snack bar, a flat on the 1st floor for the manager, and a small hall at the rear of the property for social gatherings. The ASL had previously sold their produce via an agent, Douglas Turney, and he was appointed Manager of the shop / cafe. In the Census return of 1939, the occupants of The Farm House are listed as Laura and Douglas Turney. Douglas, date of birth 15/6/1889, was single whilst Laura was widowed. Her dob was 28/1/1862 and her occupation is listed as 'Unpaid Domestic Duties'.



Also listed in the 1939 Census as being at the Farm House Cafe were another couple, Daisy and Charles Cressey. Their address is given as The Quantocks which happens to be the name of one of the smallholdings just across the lane from Rensark and The Haven on Selsdon Vale which we learnt of last month.

And then, another run of the Rabbit Warren of Research appears: A photo attributed to the 1960s taken from the top of Field 1. Tree lined Old Farleigh Road diagonally top left with the houses of Birdwood Close in the centre running horizontally, just below them is the smallholdings of Rensark to the left and The Haven right clearly showing the animal sheds of Rensark. Centre, left to right, is the tree lined Selsdon Vale down at the valley bottom.



Helen Krasner has confirmed the accuracy of the photo; indeed, it is her only photo of her old home.

BIRCH (SELSDON)

After many months of refurbishments and rewilding the previous Selsdon Park Hotel is due to open this spring as Birch (Selsdon). This is a 'sister' hotel to the award-winning Birch (Cheshunt). Birch offers guests the chance to pause and reset, so that they leave inspired, re-energised, and with new ideas and stories to tell.

The 200-acre estate has been rewilded to recreate a northern hemisphere savannah, free from human intervention. Self-sustaining herbivores including long-horned cattle and Exmoor Ponies will roam free (at a

natural density for the site) and it is hoped that, in time, endangered species native to this part of England such as nightingales, nightjars and dormice will return in abundance.

Along with 181 bedrooms, Birch (Selsdon) boasts a pottery studio, screen-printing workshop and an interactive kitchen to get creative in. There is also a reading room, arcade and screening room to switch off in. A lido (opening summer 2023), tennis courts and wellness space with gym, studios and treatment rooms. For feasts and flavours there are two restaurants and three bars.

As Birch's ethos is to reuse and minimise waste where possible, the lampshades are made from recycled glass and the fabrics from recycled textiles. Each bedroom is furnished with bedside tables crafted using wood from the Selsdon estate.



Birch's all day dining and signature restaurants will take their cue from the estate and feature freshly foraged ingredients as well as seasonal produce from the onsite kitchen garden.

As well as overnight stays, Birch (Selsdon)'s membership programme allows local people to access the whole estate for work, pleasure or both, enjoying everything on offer from co-working to wellness.

One reader wanted to share with local residents this information that he had received from Transport for London about the Scrappage Scheme accompanying the expansion of the Ultra Low Emission Zone. The £110 million fund has been designed to support Londoners on certain lower incomes, disabled Londoners, London-based charities, sole traders and businesses with 10 or fewer employees prepare for the expansion of Ultra Low Emission Zone London-wide on 29 August this year. Successful applicants will receive funding to scrap or retrofit their old, polluting vehicle.

To accompany the scrappage scheme, the Mayor and TfL are also announcing a range of ULEZ support offers from businesses for all Londoners, including additional exclusive offers for successful applicants of the scrappage scheme. This will enable Londoners to benefit from discounts and promotions on subscriptions, rentals and purchases of bicycles, e-bikes, cargo bikes, cars and vans.

It follows the Mayor's decision to expand the ULEZ London-wide from August. Already around 85 per cent of vehicles seen driving in outer London meet the standards, meaning the majority of drivers will not need to pay. The new scrappage scheme and grace periods will help drivers of the remaining non-compliant vehicles prepare.

Londoners receiving certain means-tested benefits and non-means-tested disability benefits can apply for cash grants of up to £2,000 to scrap their non-compliant cars or motorcycles. As a new feature, successful applicants can also choose to receive a higher value package comprising up to two free annual bus and tram passes and a lower cash grant.

Disabled people who want to scrap or retrofit a non-compliant wheelchair accessible vehicle will be able to apply for grants of £5,000 to reflect the higher cost of these vehicles. Disabled people can also apply for a nominated driver if they do not drive themselves. The nominated driver does not need to live at the same address as the applicant.

Charities, sole traders and businesses with 10 or fewer employees registered in London can apply to scrap a van (\pounds 5,000 grant) or a minibus (\pounds 7,000 grant), retrofit certain vans or minibuses (\pounds 5,000 grant) or scrap and replace a van or minibus with a fully electric vehicle (\pounds 7,500 or \pounds 9,500 grant respectively).

In addition to the scrappage scheme, further support will be provided for disabled people, through new and extended grace periods. The two new grace periods provide exemptions until October 2027 for recipients of

certain disability benefits (or their nominated driver) and for all wheelchair accessible vehicles and some vehicles with other adaptations. The grace periods are available to all eligible people regardless of whether they live in London, and they will apply to the current ULEZ zone as well once approved.

The new disabled benefits grace period means that anyone who receives benefits that automatically make them eligible for a blue badge will also qualify for the new grace period. More Londoners currently claim benefits that would make them eligible for this grace period than currently hold a blue badge.

Nature Notes from Ted Forsyth – Spring and Summer Migration



Many birds which breed in Europe will have spent their winter somewhere in Africa. To get to their winter quarters the birds will have converged on to one of several routes in order to cross the Mediterranean, usually those routes which minimise distance across the sea so there will be concentrations of birds at each end of the Mediterranean and also crossing from Italy. During

return migration in spring the same routes will be followed in reverse, with different species choosing to make the journey at different times. At the time of writing this note in mid-February there are already reports of

Some information about where birds migrate to and the routes they take has been obtained by attaching light metal rings to the legs of birds. When a ringed bird is caught, or the data on the ring is otherwise retrieved, a little bit of light is shone on the mystery of migration. To get more than one data point requires using thousands of rings, most of which will never be retrieved, but with modern miniature electronics it is possible to attach a very light radio tag and trace the bird while it is migrating. The BTO (British Trust for Ornithology) has done this with several Cuckoos so if you do a web search for BTO CUCKOOS or BIRDTRACK CUCKOOS you will see information on the current positions of the birds returning to UK. From the viewpoint of the UK the earliest arrivals involve Ring Ouzels, Sand Martins and Wheatears appearing in March or even earlier, with many other species making an appearance in April or even May.

Thousands of Black Kites cross from Africa to Spain in February and subsequent months accompanied by smaller numbers of many other species. Though their ultimate destination will lie further north on the European continent inevitably some individuals will deviate from the main route and may follow a route taking them over UK.

In 2022, in April, more than 100 Golden Orioles were found scattered over the British land mass. This is weather dependent and the birds do not remain for long but it is worth listening for the unmistakeable fluty notes of the birds or keeping your eyes open for a glimpse of the vivid yellow and black colouring of the males. Females tend to be a greenish colour. The species has been recorded more than once in Selsdon Wood.

While Ospreys tend to be early arrivals back at their nests, other raptors prefer warmer weather and their appearance can occur in any month up to June. In recent years there have been visits from, probably solitary, Short-toed Snake Eagle, Booted Eagle, Egyptian Vulture and others.

Swifts usually arrive in flocks and can be joined by species like Alpine Swifts and Hobby Falcons so it can be worth carefully examining any swifts that are seen.

Many of the species mentioned so far do not usually breed in Britain but there are many which do, and though most will not stop to breed in Selsdon Wood some could be seen briefly while on migration. Garden Warbler, Willow Warbler and Lesser Whitethroat do not usually stay long enough to attract a mate and hold territory but are detected often enough for it to be a possibility. In the past our summer residents have included Tree Pipit, Spotted Flycatcher and even Tree Sparrow and there is always the possibility they might return. For other species the wood might not provide the appropriate habitat and any sighting is likely to be of birds on the move. This is true of birds like Honey Buzzard which tend to fly over towards the end of May or June as they need to feed on well-developed nests of bees and wasps.

The rule during migration seems to be "Expect the unexpected".

Bird's Eye View John Birkett, RSPB Croydon Local Group



As I write this, the bright late-winter sun is burning off the overnight frost. From where I sit, I can see a neighbour's ivy-covered tree. The ivy berries are now ripening, forming a good food source at this time of year. Blackbirds and redwings are flitting around grabbing the berries, while a couple of woodpigeons are sitting in the tree hoovering up what they can reach from their perches. All this is probably upsetting the pair of magpies that nest in the same tree. Meanwhile, a charm of 20 goldfinches have landed in a silver birch nearby and are foraging around in there. My overwintering male blackcap turns up on a feeder from time to time, while a couple of chaffinches and a starling are searching the lawn for food.

A few days ago, a small flock of siskin decided to land in an alder tree by the front garden; a bird that has been in short supply round here this winter.

With spring not far off, I am now hearing more birds announcing their presence. Several robins and a couple of dunnocks have been singing away and occasionally seeing off rivals. At dawn and dusk, I may be lucky enough to hear a song thrush singing its repeating phrases. And a pair of collared doves are also beginning to get it together.

It may not be as bird rich as going to a major nature reserve, but just looking out from your kitchen window can give you pleasure and comfort in times of stress (and you can stay in the warmth of your own home).
